- 7) CURRENT ISSUES – COMMISSIONER REPORTS
  - a) Grants: We recently received an email from the Office of Education asking us to pay an invoice they sent to the secretary in June, 2020 for the \$9000 we granted them in the 2019 grant cycle. This invoice should have been sent by the Office of Education to Karen Clower, at the address noted in the RFP. Subsequently, the secretary asked Karen Clower, Deputy County Administrative Officer, to have this invoice paid, and she has asked for the wording in the agreement we have with the Office of Education, and the date by which the county should have been notified for payment. This may mean we have much less money in our account. This issue has not been resolved. We have sent a request to the Board of Supervisors to approve our recommendations to fund the following proposals:
    - i) Humboldt County Office of Education. “Classroom Aquarium Education Program.” \$3000
    - ii) Natasha Hope Ficzytz, MSc student, HSU Dept of Fisheries Biology. Measuring Exposure to Domoic Acid in recreational Humboldt Bay bivalves along ocean to estuary transects” \$1500
    - iii) Micaela Szykman Gunther, Dept of Wildlife, HSU. “Novel insights into the diet of local carnivores” \$1500
  - b) Abatement: Discussion of abatement – Commissioner James Clark
  - c) Humboldt Bay National Wildlife Refuge – Update by Commissioner Phil Grunert regarding the Refuge including handicap access, alterations being made by the refuge, successful hunts on the Refuge, etc.
  - d) Eel River Groundwater Working Group: Commissioner Hollie Hall is monitoring this group.
