- Supervisor Arroyo let Probation staff know that the Elections office is looking for ways to expand their outreach for voting eligibility. Director Ghisetti stated that if the Elections office had information that they would

like Probation to provide its clients, that Probation would be more than happy to facilitate that exchange through tools such as Career Hub.

- Lastly, Supervisor Arroyo had informed Probation that she had just received a tour of the Eureka VA facility and found that they had received funding that is allowing them to provide services to non-VA individuals. This could be another resource for Probation clients.
