For a small street, there is a great deal of traffic, particularly related to the school. Pedestrians include parents and children, members of the local elementary school community, individuals accessing the bus stop, dog walkers, and people walking for health. We believe improving pedestrian safety would be beneficial to all in our community and encourage exercise, community building and alternate means of transportation.
