Project 1: Firefighter PPE

The Blue Lake Rancheria Volunteer Fire Department (BLRFD) was founded October of 2018 out of need to protect tribal assets and community members. The department is in its infancy and much more planning, equipment and resources are needed. The BLRFD Board was formed in November 2018 and work began with the hiring of a Fire Chief.

The Fire Chief oversaw the purchase of a used structure truck. The next step, with BLR FD Board guidance, was creating the volunteer crew. A meeting was held and Rancheria; members, employees and residents stepped forward to create the core crew of 15.

The board determined that next step would be acquiring personal protection equipment (PPE) for fire fighters (i.e; turn outs, boots and helmets). With the salary of the fire chief and purchase of the truck the budget has been stretched and without assistance the tribe cannot provide the PPE required for the crew.

The tribe is requesting 80% (\$43,284.) of the costs of firefighter PPE. The tribe's fire budget will provide the other required 20% (\$10,821.).

Project 2: Training Aid

BLRFD Fire Chief has been communicating with Arcata FD to host training tower at the Rancheria for training of Humboldt County FF's who reside in close proximity to the Rancheria (Northern Humboldt and other Tribal FD's).

The tribe is willing to host the pad necessary to provide the training tower for further training of Humboldt County FD's, but lacks the funding to construct it.

It was recommended by tower manager to have a concrete pad 28' x 66' with 10 foot of black top surrounding that to accommodate the tower.

The tribe is requesting 80% (\$19,200) of the costs for Fire Training Tower pad. The tribe will provide the other 20% as a match (\$4,500).

The tribe has been host to much training at the Rancheria through its Resiliency Training & Innovation Center (RTIC). Anyone is welcome to attend training at the Rancheria, both tribal and non-tribal. The Rancheria welcomes the opportunity to host the training tower free of charge to local FF's to build local resilience.
