Advantages of the proposed Sun Ridge CAD/RMS system include:

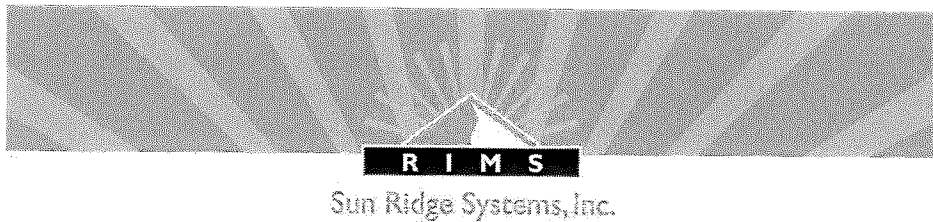
- State of the art specialized single database system.
- Sharing the same system as other Humboldt County law enforcement agencies, moving towards a regionalized data sharing model.
- Enhanced abilities for offender tracking, sex registrants, wanted subjects, parolees, probationers, and AB 109 incarceration releases.
- Merges and shares vehicle data intelligence files to assist with the stolen vehicle program and interface to the State of California Statewide Traffic Collision Reporting System.
- Provides link analysis capability for crime analysis on persons or associated groups who have criminal background connections.
- Establishes and/or upgrade mapping databases.
- Implements GPS tacking capability for patrol units.
- Accurately runs and locks down reports and statistics for the State's Uniform Crime Report Audit.
- Consolidates data entry for property and evidence modules to reduce data entry for each property item.
- Improves quality of information technology involvement by reducing system errors, lockouts, data entry corrections, crime statistic problems and general software incompatibilities.
- Provides officers and citizens with updated mapping report and analysis.
- Increases the efficiency and automation in our crime analysis ability and method of operation tracking.

Additionally, the software allows interface with the 9-1-1 telephone system, the California Law Enforcement Telecommunications System (CLETS), and other databases that increase regional interoperability. Our goal, with Humboldt's other law enforcement partners, is to eliminate redundant work processes between law enforcement, the county jail, court administration, and the District Attorney's Office.

Once we receive the extracted data, we will evaluate it to determine which items may be converted into and merged with the Fortuna RIMS. As part of our standard data conversion, we attempt to convert the following items. In some instances, all data may not be available or suitable for conversion.

- People: Including person name, DOB, contact info, description, ID#'s, officer safety notifications, log entries for connections to cases, for citations and for field contacts
- Arrest: Arrestee, date, time, charges, counts, offense level, dispo, booked/cited out
- Vehicles: License, state, year, color, type, log entries for connections to case and for field contacts
- Cases: Location, date reported and date occurred, classification/type, offenses, case dispo and date of dispo, persons, vehicles, narratives and supplements
- Property in cases: category, article, status, description, brand, model, item #, property code, locations, value-stolen, recovered, damaged, disposition and officer
- Premises: Common place name, address, contact person, contact phone number, alarm
- Streets: (if electronic street file is available), street name, intersections with block ranges
- Officers: Name, ID

**Mapping.** Our In Station Mapping product requires ESRI ArcView or Google maps. Our price does not include the cost of the ArcView licenses. ESRI ArcView maps require a source data file provided by you. If you choose to use Google Maps as your map source, Sun Ridge Systems pays the licensing fees to Google; there is no charge to you.

Our Mobile Mapping product also requires either ArcView or Google Maps. There are no third party map costs if you choose to use Google Maps as your map source in the mobiles.

If you purchase ArcView, you will need one copy of ArcView GIS v10.1 (or later) that can be used for the first position, and then a copy of ArcGIS 10.1 (or later) Runtime Engine for each additional in-station or mobile unit that will use RIMS Mapping.

**Bar Coding Equipment.** Worth Data is the manufacturer of the bar coding equipment. It includes a base station and wireless scanning terminal. These devices include a 2-year manufacturer's warranty and are not maintained by Sun Ridge. You must also purchase an inexpensive printer and labels for bar coding labels: DYMO LabelWriter 450 Turbo Label Printer and Dymo Labels # 30256. They are available at your local computer/office supply store or on the Internet.
