 Market Alternative [Maximum Flexibility Alternative]
- 4) Status Quo with Design Guidelines Alternative

A significant amount of comment occurred amongst the MMAC and the community related to the alternatives. The vast majority of the comments indicated support for a reduction in traffic on Central Ave. and consideration for the housing situation in Mckinleyville.
