### Minutes

#### I. Call to order

Chief of Probation Shaun Brenneman called the meeting to order at 12:15pm. In attendance was Justin Nadigoo, Michelle Tucker, Wes Harrison, Coral Sanders, Jessica Smith, and Justin Braud.

Chief Brenneman gave a brief overview of the premise of General Public CCP meetings.

#### II. Report out on CCP Executive Committee meeting 06/17/2020

Chief Brenneman provided a report out of the Executive Committee meeting:

- Drug Medi-Cal information
- Approval of funding for a local Crisis Intervention Training.
- Extension of RCAA case management contract to September 30<sup>th</sup>.

#### III. Update on CCP plan implementation

*Brief review current status of CCRC staffing and Community Corrections Partnership plan program service elements and other executive-body approved actions.*

Wes Harrison/Crossroads: provided some insight on how Crossroads will navigate Drug Medi-Cal and what the program will look like for clients. Crossroads has been 100% Drug Medi-Cal certified.

Coral Sanders/Probation: transferred staff to CCRC after an unexpected vacancy arose. There are now only 3 staff in the Supervised Release Program. CCRC probation services have resumed.

Shaun Brenneman/Probation: The HCCCP budget is tied to sales tax and licensing fees. There will be a discussion regarding this potential budget impact in the future.

A discussion took place regarding Drug Medi-Cal.

- What the process for Probation clients will look like.
- What happens to clients who have been released until they activate their Drug Medi-Cal.

- The best course of action to take if a client has a relapse.

Jessica Smith/Humboldt Harm Reduction: inquired regarding the services that could be available to those being released from the jail to reduce substance use and the potential to overdose as well as what is Probations and Corrections role in assisting with this.

- Shaun Brenneman: the services one receives is dependent upon their level of supervision when released as well as the type of their involvement in the criminal justice system.
- Coral Sanders: provided information on the current services being offered to those who have been released that suffer from substance abuse as well as the steps being taken for those with substance abuse issues while they are incarcerated.
