The bill is scheduled to go back to the legislature in January 2018. Connie Beck reported that DHHS has staff trained to use Narcan. Mike Wilson reported that he asked for this item to be placed on the agenda and thinks it is important that the Board be aware of this, if the bill is approved it will be up to each county to decide if they want this in their county. This is something the Board needs to track and be aware of as there will be a lot of discussions coming up with cities and counties about this. Lance Morton asked if the Board could get a presentation in the future. Connie Beck reported we need to look at the big picture regarding needle exchanges and the processes.
