<p>July 18 – August 12 - Elect Code: Sections 10510, 13307, 13311</p>	<p>Declaration of Candidacy During this period, candidates must file declarations of candidacy and nomination petitions. The declaration of candidacy shall be executed in the elections official's office. Candidates must pay the nonrefundable filing fees. (School Districts and most Special District candidates are exempt.) A candidate shall not be required to execute a nomination paper if the number of in-lieu signatures that meets the nomination requirement on the in-lieu petitions equals or exceeds the minimum number required.</p>
<p>August 1 - Gov Code: 8400, 84218</p>	<p>Semi-Annual Campaign Statement (460/470) due. Last day to file semiannual campaign statements, if required, by all candidates and committees. For period ending June 30, 2022.</p>
<p>August 10 – November 8 - Gov Code: 82036, 84203, 84203.3</p>	<p>24-Hour contribution reporting period begins (496/497). During the 90 days immediately preceding an election and including Election Day, the following contributions that total in the aggregate of \$1,000 or more must be reported within 24 hours to the county elections official.</p> <ul style="list-style-type: none"> • 496: File if independent expenditures of \$1,000 or more are made. • 497: File if a contribution of \$1,000 or more in the aggregate is received from a single source. • 497: File if a contribution of \$1,000 or more in the aggregate is made to a candidate or measure being voted upon November 8, 2022, or to a political party committee. • The recipient of a non-monetary contribution of \$1,000 or more must file a Form 497 report within 48 hours from the time the contribution is received. <p>May be emailed to Humboldt_Elections@co.humboldt.ca.us</p>
<p>August 12 - Elect Code: 13307</p>	<p>Deadline to File Candidate Statement Last day for nominees for city, county, district, or any other local agency to file a statement of qualifications, not to exceed 200 words (unless district chooses to allow longer), to be included in the Voter Information Guide. The statement shall be paid for at the same time that it is filed. Cost information is available from the county elections office.</p>
<p>August 12 - Elect Code: 8800</p>	<p>Withdrawal of Candidacy Final day a candidate for a local office can withdraw his/her name from the race. If there is an extended candidacy period, the final day to withdraw will be August 17, 2022.</p>
<p>August 13 -17 - Elect Code: 8022, 8024</p>	<p>Extension of Candidacy Period If an incumbent has not filed a declaration of candidacy by August 12, 2022 there will be a five-day extension allowing non-incumbents to file nomination papers.</p>
<p>September 29 - Gov Code: 84200.5, 84200.8(a)</p>	<p>First Pre-Election Campaign Statement (460) due. Last day to file campaign statements for candidates and committees covering the period from July 1, 2022 to September 24, 2022.</p>
<p>October 27 - Gov Code: 84200.5, 84200.8(a)</p>	<p>Second Pre-Election Campaign Statement (460) due. The last day to file campaign statements for candidates and committees covering the period from September 25, 2022 to October 22, 2022.</p>

<p>November 8 - Gov Code: 82036, 84203, 84203.3</p>	<p>Last day of 24-hour contribution reporting (496/497)</p>
