1. Can the project be developed without removing any trees? (Y/N)

3. Does the applicant have either a Humboldt County permit or interim permit for commercial cannabis cultivation? (Y/N)
4. Are all of the applicant’s Humboldt County cannabis cultivation taxes current? (Y/N)
5. Are all of the applicant’s County cannabis cultivation permit fees current? (Y/N)
