Eligibility Criteria: (Only applications with “Yes” answers to all the following questions are eligible to apply for funding)

1. Can the project be developed without removing any trees? (Y/N)
2. Does the applicant have a California state license for commercial cannabis cultivation? (Y/N)
3. Does the applicant have either a Humboldt County permit or interim permit for commercial cannabis cultivation? (Y/N)
4. Are all of the applicant’s Humboldt County cannabis cultivation taxes current? (Y/N)
5. Are all of the applicant’s County cannabis cultivation permit fees current? (Y/N)
6. Is this a true statement: "the property is NOT connected to the commercial power grid"?* (Y/N)
* For clarity: A property is eligible if the commercial cannabis operation is not connected to the power grid, even if it has an existing residence or approved use that is connected.

Note: While any of the above answers are marked “N”, the following text appears in red: “Since one or more responses to the above questions is “No”, the application is not eligible for this funding program and will not be considered for funding.”
