**During the third quarter of the MOU with Humboldt County the Kneeland Volunteer Fire Department responded to two out-of-district calls. These two incidents included:**
  - **A motor vehicle accident with injuries (1/1/17) involving four responders for five hours each as well as rescue vehicles 8946 and the Chief's response vehicle;**
  - **A medical assist for an EMS crew (3/22/17) involving three responders for 2.25 hours each as well as rescue vehicle 8946**
