**Your signature is missing on your vote by mail ballot envelope.**

The Humboldt County Office of Elections received your vote by mail ballot envelope without your signature. By law, a voter’s signature must be verified before the ballot may be counted.

**READ THESE INSTRUCTIONS CAREFULLY BEFORE COMPLETING THE STATEMENT.  
FAILURE TO FOLLOW THESE INSTRUCTIONS MAY CAUSE YOUR BALLOT NOT TO COUNT.**

In order to ensure that your vote by mail ballot will be counted, your statement must be received by the Humboldt County Office of Elections no later than 5 pm two days prior to the certification of the election.

Fill out and sign the Unsigned Ballot Envelope Statement. It can be returned to the Office of Elections in any of the following ways:

- **Come to our office in person.**

Monday through Friday, 8:30 am to noon and 1:00 to 5:00 pm  
**SIGN** your original vote by mail ballot envelope or deliver this completed Unsigned Ballot Envelope Statement. This must be done before by 5:00 pm two days prior to the certification of election.
- **Deliver your signed statement on Election Day** to a polling place in Humboldt County before the close of polls (8:00 pm) on Election Day, March 3, 2020.
- **Mail your signed statement in the enclosed envelope.** The Unsigned Ballot Envelope Statement must be received at our office before 5:00 pm two days before election certification. Postmarks will not count. If you return your statement via mail, **YOU MUST PLACE POSTAGE** on the return envelope.
- **Fax or scan and email the signed statement to our office.** It must be received at our office before 5:00 pm two days before election certification.

**UNSIGNED BALLOT ENVELOPE STATEMENT**

I understand that if I commit or attempt any fraud in connection with voting, or if I aid or abet fraud or attempt to aid or abet fraud in connection with voting, I may be convicted of a felony punishable by imprisonment for 16 months or two or three years. I understand that my failure to sign this statement means that my vote by mail ballot will be invalidated.
