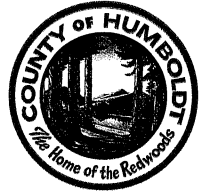

**I. QUARTERLY NARRATIVE**

**A. Results/Outcomes**

1. Please describe the Measure Z activities completed.

**During 1st quarter of the Measure Z funding from Jul 1, 2019 to Sep 30, 2019 the following Measure Z activities were completed.**

**Over the last Quarter (July to Sept 2019), the FPD agent at the Humboldt County Drug Task Force assisted in seizing over several pounds of Heroin, Cocaine, Methamphetamine and prescription Narcotics. In addition, the DTF has seized firearms, commercial growing equipment and large sums of currency related to illegal drug sales.**

2. How many people have been served and how.

**During the 1<sup>st</sup> quarter Measure Z funds are continuing to make a positive impact in our department and community. The FPD DTF agent serves the entire population of Humboldt County. Since placing an agent of the Drug Task Force, the Eel River Valley has seen a dramatic rise in drug enforcement activity as well as a rise in drug enforcement activity countywide. The FPD agent at the DTF has executed several search warrants, been involved in undercover operations and has worked with confidential informants in the drug trade.**

3. Who has benefited from the enhanced services.

**The Fortuna Community, Eel River Valley and the entire County of Humboldt continues to see great benefits with the addition of this position to the Drug Task Force.**

4. What difference did Measure Z funding make in our community and for the population you are serving? **Measure Z funding of the Drug Task Force agent has given the FPD a direct conduit to the DTF and the DTF has gained a valuable agent. Our agent brings a great deal of knowledge and expertise of the drug activity occurring in the Eel River Valley. The addition of this agent has resulted in a much higher level of enforcement operations in the area and countywide. Our DTF agent has been responsible for several arrests during this quarter for drug sales and transportation of drugs. Several Search warrants have been served in the ERV by the DTF related to drug sales and trafficking.**

5. Please quantify the long-term impacts of your project. This would be for the entire time period that Measure Z has funded your project.

**The Fortuna Police Officer assigned to the Drug Task Force has been Measure Z funded since August 2015. Since the inception of the FPD agent, our community has seen a direct and effectual impact on drug sales and activity in our community and the county. We have seen DTF drug related arrests and operation skyrocket in the ERV, which has resulted in many POUNDS of Heroin and Methamphetamine being seized and several large-scale drug distribution operations being busted. Many of the largest busts for Heroin and Methamphetamine have been made in the Eel River Valley.**

6. Describe any unanticipated impacts of receiving Measure Z funding, positive or negative, not already described above.

**The Measure Z funding of the Drug Task Force agent has been nothing but overwhelmingly positive and has a dramatic impact on the safety and livability of our community. The addition of this position has resulted in many more drug investigations, operations and arrests in our community and countywide, making the entire county a safer place to live, work and enjoy.**
